## New York State Alliance of Sex Offender Service Providers Has 20th Anniversary

Identified service providers working with juvenile sex offenders in New York State were invited to a networking meeting on October 26, 1988 at St. Anne Institute in Albany at which time The New York State Alliance of Sex Offender Service Providers (NYSASOSP) was established. The meeting was sponsored by Marilyn Etcheverry, Director of Preventive Services for St. Anne's Institute, and Gary Hook, Adolescent Sex Offender Program Specialist for the New York State Division of Youth. The 26 attendees included Richard Hamill, PhD (current President of the Alliance) from St. Anne Institute Regional Sex Offender Program, Catherine Diana, LCSW (current Board member) from the LaSalle School, Terry Tamer, Department of Correctional Services, (former Board member) representatives from Orange County and Rockland County Probation Departments, representatives from the NYS Department of Correctional Services, the NYS Division for Youth, the NYS Department of Social Services, the NYS Police, the NYS Office of Mental Health, Berkshire Farm Center, People Against Sexual Abuse and the Brooklyn Sex Crimes Prosecuting Center. Consensus was reached on the critical need for training and a committee composed of Marilyn Etcheverry, Gary Hook, Terry Tamer and Kathy Zasloff was formed to develop a proposal for a training grant through the Children's Justice and Assistance Act.

Subsequently, a grant proposal was submitted and approved for \$30,000 in which the Alliance agreed to provide a four-day training on the assessment and treatment of sex offenders in three geographic areas of the state, to develop a state-wide directory of service providers and to sponsor a national conference on juvenile sexual

offending. In 1989 regional trainings were provided by state and national experts in the field of assessment and treatment of sex offenders and a state-wide service directory was developed and distributed. The Alliance in 1990 also sponsored the Fifth National Training Conference of the National Task Force on Juvenile Sex Offending, a function of the National Adolescent Perpetrator Network. The conference drew more than 600 participants from across the United States including Alaska and Hawaii and from Canada, England and the Netherlands.

Since then, the Alliance has sponsored and co-sponsored numerous regional trainings across the state by nationally and internationally recognized experts in the field of sex offender assessment, treatment, and supervision to enhance service providers' skills. In May 1996, the Alliance sponsored the first statewide annual conference for service providers working with child, juvenile and adult sexual abusers. It has continued this tradition and in May, 2008, the Alliance hosted its 13<sup>th</sup> annual statewide conference in Saratoga Springs.

The NYSASOSP identified its mission as: to reduce the level of victimization; to promote the increase, uniformity, and quality of assessment and treatment services for juvenile and adult sex offenders; to promote the development of a fully integrated continuum of services to sexual offenders; to promote legislation on issues and funding for programs impacting sex offenders and survivors; to promote offender accountability through restitution, mediation, treatment, supervision and incarceration; and to promote community safety through confinement of sex offenders not amenable to community-based services.

Alliance members actively participated in the development of the Governor's Task Force on Rape, Sexual Assault and Child Sexual Abuse report submitted to Governor Mario Cuomo in April, 1990.

The Certificate of Incorporation for the New York State Alliance of Sex Offender Service Providers was filed on October 1, 1997. The Alliance supported the establishment of the New York State Chapter of the Association for the Treatment of Sexual Abusers.

Along with the NYS Chapter of ATSA, the Alliance supported the Capital District Center for Sex Offender Management planning grant through the Center for Sex Offender Management. In accord with its mission to support community safety, the Alliance has issued a number of position papers and has actively worked with the New York State legislature to educate legislators on the issues of sexual offender assessment, treatment and supervision. For example, Alliance and NYSATSA Board Members joined together to lobby the state legislature and Governor's Office when the Civil Commitment Laws were being considered. The Alliance continues to develop position papers on issues that affect children with sexual behavior problems, juvenile sexual abusers and sex offenders and victims of sexual abuse and sexual assault and to engage in additional activities that promote its mission.

The New York State Alliance of Sex Offender Service Providers celebrated its 20<sup>th</sup> anniversary in 2008. Happy Anniversary!

The U.S. Department of Justice announced improvements to the Dru Sjodin National Sex Offender Public Web site (NSOPW) and a new internet domain name, [www.nsopw.gov](http://www.nsopw.gov). NSOPW is administered by the Office of Justice Programs' (OJP) Office of Sex Offender Sentencing, Monitoring, Apprehending, Registering, and Tracking (SMART). These changes were announced on the fifth anniversary of the disappearance of Dru Sjodin, a University student who was never seen again after she left her job.

## **DIVISION OF PROBATION AND CORRECTIONAL ALTERNATIVES ISSUES DRAFT SEX OFFENDER HOUSING GUIDELINES**

Revisions to the Sex Offender Management Act resulted in a new chapter of the law that will go into effect on January 23, 2009. Part 365 states "Sex Offender Housing Procedural Guidelines" The DPCA draft lists Pre-Plea or Pre-Sentence Procedures; Supervision Procedures; and Interstate Transfer Procedures. In this draft, probation departments completing pre-sentence investigations are charged with investigating the defendant's residence or proposed residence for individuals charged with a "sexual assault" or otherwise deemed level 2 or level 3 sex offenders. Investigating officers are asked to consider if any known victims or potential victims (presence of persons under 18 years old) reside near or with the offender, as well as proximity to schools and entities with "vulnerable populations." "The probation department should summarize its findings and make a recommendation to the court as to the appropriateness of defendant's residence or proposed residence..."

This draft was sent to Probation Directors in New York State for comment. DPCA "will be working with probation departments in developing our emergency regulation in this area to ensure that they are fair and reasonable and consistent with the law's intended goal."

## Sex Offender Courts In New York State

Seven counties in New York State have specialized Sex Offender Courts. (Erie, Kings, Oswego, Orange, Westchester, Nassau and Suffolk counties.) These courts were developed to provide optimal supervision and court response to sexual offenders. This process includes numerous stakeholders with a primary purpose of ensuring that sex offenders abide by the conditions of their probation as well as watching out for community safety. One of the benefits of such a specialized court is the development of standardized conditions of probation that sex offenders are expected to follow as a means to help themselves keep from committing another sexual offense.

The Sex Offender Courts were not developed with the intention of being similar to drug courts or other such treatment courts. For example, the Erie County Sex Offender Court (as well as others) has compliance hearings for individuals who have been found to be in violation of probation, but remain in the community. Some of these individuals may have had a brief incarceration or the addition of electronic home monitoring to their supervision by Probation as a result of the violation. Following their sentencing on the violation, these offenders remain in treatment, but under closer scrutiny of the Court via the compliance hearings. The court determines the frequency of these hearings and if any additional supervision and/or treatment interventions are necessary to help keep the offender from committing another offense.

Other individuals and agencies are brought into the supervision and recovery process for these offenders through the specialized sex offender courts. For example, treatment providers play an integral role in providing information about the offenders risk for offending, if and how he is lapsing in treatment, as well as recommendations that contribute to providing for community safety. Information from others, such as victim services providers, lawyers, polygraph examiners, and other criminal justice agencies can also be obtained by the Court for the purpose of sex offender oversight.

According to Alisa Klien of ATSA, "The Center for Court Innovation has been working for a few years now with New York State to develop and expand its network of county-based sex offender courts." She also noted that further information about this concept and the development of such courts, is available on line, such as those listed below.

### **New Juvenile Residential Program Opens**

## TREATMENT AND REENTRY PRACTICES FOR SEX OFFENDERS

The following text is quoted from Reagan Daly. *Treatment and Reentry Practices for Sex Offenders: An Overview of States*. New York: Vera Institute of Justice, 2008.

“Over the past 15 years, the response of the criminal justice system to people who have been convicted of a sex offense has become increasingly punitive, relying heavily on incarceration. Yet, a consequent increase in criminal justice costs has led some states to reconsider their response to sex offenders. Concerns about public safety and the protection of victims remain the primary focus, but many states have also invested in treatment and reentry programs as alternatives to incarceration for some people. Although the content and structure of treatment and reentry programs vary considerably from one jurisdiction to another, few if any resources provide criminal justice officials and policymakers an overview of these programs or a comparative assessment of their effectiveness. This report attempts to address these issues by providing an overview and analysis of existing treatment and reentry practices for sex offenders who are involved with the criminal justice system. It focuses, specifically, on four broad areas of practice: treatment in prison, treatment under community supervision, reentry programming, and community supervision. Interviews with state officials and treatment providers from 37 states that responded to our survey revealed several findings:

- In both prison and community settings, the treatment of sex offenders is generally grounded in evidence-based practices, especially cognitive-behavioral therapy. In general, treatment is much more available in the community than in institutional settings.
- In most of the participating states, community-based treatment for sex offenders is supported, at least in part, by collecting fees from those in treatment—a circumstance that may limit access to these programs.

- Standardized risk assessment tools such as the STATIC-99 are now widely used nationally in both prison and community-based treatment programs. Needs assessment tools, especially the ACUTE, are becoming more prevalent in community supervision.
- No reentry initiatives were found that specifically target sex offenders. Although eligible for general reentry programming in most states, people convicted of a sexual offense have few, if any, options for reentry programming that addresses their unique needs.
- Correctional institutions and community supervision agencies in most states share information about the case histories and treatment plans of sex offenders who are returning to the community from prison. Research suggests that this type of inter-agency communication can help reduce recidivism.
- In general, community supervision agencies manage risk and provide services. Research suggests that this is an effective approach to reducing recidivism.
- A limited number of states are conducting research on their own treatment, reentry, and supervision initiatives. Almost no studies have examined these programs from a cost-benefit perspective.”

This work contains an overview of the different Prison-Based and Community-Based Sex Offender Treatment Programs, as well as Reentry Programs. The Appendixes contain “State Overview Tables Of Community Supervision Practices” and “Individual State Templates.” “Recent Trends in Treatment, Reentry, and Community Supervision Practices” are also discussed.
